| 1) Are you completely familiar with the operation of your shotgun?
If you are NOT, let us know and we will assist you with its operation. | Circle one: YES NO | INITIALS |
| 2) You MUST wear EYE protection and EAR protection at all times. NO EXCEPTIONS! | | _____ |
| 3) Always keep your gun BARREL pointed in a safe direction away from all people, structures, vehicles and other property. The BARREL must be pointed at the ground or straight up in the air when not shooting. | | _____ |
| 4) Keep actions open at all times when not in/on the shooting station. The gun must be EMPTY with the action open when you leave a shooting station. | | _____ |
| 5) DO NOT load your gun until you are in/on the shooting station. NEVER enter or leave a shooting station with a loaded gun. NEVER WALK with a loaded gun. | | _____ |
| 6) Load one (1) shell at a time for singles and a MAXIMUM of two (2) shells for doubles.
Once the gun is loaded the barrel must be pointed down range. | | _____ |
| 7) Use only APPROVED SHOT SIZES of 9, 8.5, 8, 7.5. NO LOADS over 3 3/4 dram or shot sizes larger than 7.5. | | _____ |
| 8) If you have a misfire, keep the gun pointed down range FOR ONE (1) MINUTE before opening the breech. | | _____ |
| 9) Never look down the barrel of a gun with a closed breech. Treat every gun as loaded gun. | | _____ |
| 10) Never change or tighten chokes with a loaded gun. | | _____ |
| 11) Please make sure Trap, Skeet, 5-Stand and Sporting Clay fields are CLEAR before shooting. | | _____ |
| 12) Capital City Clays is located on an Austin park and is a wildlife refuge. NEVER fire your shotgun at ANY wildlife. | | _____ |
| 13) You MAY NOT SHOOT after consumption of alcoholic beverages, illegal drugs or any prescription drugs or chemical substances that impair your mental or physical capabilities! | | _____ |

ASSUMPTION OF RISK and INDEMNITY AGREEMENT

In consideration for my being permitted to participate in clay target shooting activities ("Shooting Activities") at Capital City Clays ("The Club"), located at 8707 Lindell Lane, Austin, Travis County, Texas ("the Premises"),

I agree as follows:

I acknowledge that clay target shooting is an inherently dangerous activity involving inherent risks, hazards and dangers for anyone, which cannot be eliminated. I am voluntarily participating in shooting activities at the club with full knowledge of the inherent risk, hazards and dangers involved and hereby assume and accept, on behalf of myself, my heirs, my successors, my executors, my administrators and my personal representatives, any and all risks of injury or death associated with my participation in shooting activities and presence on the premises.

I, for myself, my heirs, my successors, my executors, my administrators, my personal representatives and for any organization I represent, hereby knowingly and intentionally waive and release, indemnify and hold harmless the Club, the city of Austin, the state of Texas and any lessor or lessee of the premises and their officers, trustees, shareholders, directors, attorneys, employees, sponsoring agents, volunteers, other participants and successors and assigns (together the "Releasees") from and against any and all claims, actions, causes of action, liabilities, obligations, suits, judgments, costs, expenses (including reasonable attorney's fees), and damages (including but not limited to damages associated with personal injury, loss, suffering, paralysis or death and damage to personal property) arising out of, associated with or relating in any way to (I) my presence on the premises, my participation in shooting activities, my participation in any event conducted on the premises and my use of or involvement with any services or equipment provided by the club, including but not limited to acts or omissions of negligence, gross negligence, strict liability, or any other nature, whether foreseeable or unforeseeable, caused or alleged to be caused, in whole or in part, by me, the organization I represent, or my guests and (II) the Releasees' presence on the premises, the Releasees' participation in shooting activities, the Releasees' participation in any event conducted on the premises and the Releasees' use of or involvement with any services or equipment provided by the club, including but not limited to acts or omissions of negligence, gross negligence, strict liability or any other nature, whether foreseeable or unforeseeable, caused or alleged to be caused, in whole or in part, by the Releasees.
